6:20 PM Architectural and Landscaping Discussion: Board reviewed the need to remove a dead tree located in island off of 156th Street. Vicki contacted John Wynn, City Forester. Mary will place ribbon on the tree and city will remove. Vicki will contact John Wynn to coordinate tree removal.

Update on sprinkler, light and plug repairs in both the neighborhood park and entrances. All items are repaired, except for the electrical outlet in the median off Maple St. Board decided to cap power outlet instead of repair. 2 lights are out on the Maple street entrance into the neighborhood. Hannah will follow-up with electrician for repair. Board also requested the timers be inspected as well.

Board voted to replace two dead burning bushes located off Maple Street.

Invoice was submitted for spring landscaping clean up, stump and tree removal for entrances and calming devices.

Keith Neff will investigate costs for doggie waste bags for Neighborhood Park; revisit topic at next month's meeting. Keith was not in attendance, table till next month.

Board agreed to coordinate neighborhood volunteer event to mulch trees along Maple St with local Boy Scout troop. Robert Hassenstab will volunteer front loader, city will provide mulch. Doug Kline is the scout master. June 29th is the proposed date at 09:00. Jon will post volunteer event to Nextdoor. Additional volunteers are needed to assist with the project.

Discussion: Neighborhood watch update. Steve is setting up initial meeting in July on his block, 4 homes have expressed interest.

City monitored speed on Sprague St from 156th to 160th. Average car count was 2000+ per day and the average speed was over 32mph. Both findings should allow for additional speed controls. Possible solutions are: do nothing, remove calming devices and install speed bump or add one speed bump in conjunction with current calming devices. Bruce is evaluating options and will inform board of suggested option.
