- Citizen Patrols have been active in Omaha for 15 years and now have approximately 35 patrols
- Act as "Eyes and Ears" for the Omaha Police Department for visualize and report any activity
- Typical neighborhood roster would be 50 members and each "team" would work I weekend per every 4 -6 weeks (volunteers).
- Training meetings are held once per quarter at the NW Precinct Office 10145 Weisman Drive from 6:00 PM until approximately 10:00 PM and retrain every two years or as situations dictate.
- Can provide "drive by" checks for neighborhood businesses too.
- Designated member of neighborhood patrol must attend monthly meetings for updates.
- Radios can be used/purchased for contacts, signs can be placed on neighborhood light poles and magnetic signs on "patrol vehicles".
- Special dates for patrols can be designated such as Halloween, School Starting/letting out, Prom Night and especially weekends when suspicious activity most likely takes place.
- Funding for equipment could be attempted in asking for grant money from Peter Kiewit, Mutual of Omaha, Mayor's Office etc. as there is an expense involved in mileage/gas, radios, batteries, safety vests etc.
- Additional information will be sent to Vicky and Sara for follow up due to high interest from Board. Going forward will require volunteer commitments from neighbors. Time commitment would involve most likely a few hours on weekend nights or as needed due to activity.
- Background checks must be done before being a patrol member and cost is taken care
 of by Omaha Police Department. Support from Mayors' office, Sheriff Dunning and OPD
 is noted as being positive.
