If you are requesting a paint color change for the exterior of your home, you must select a preapproved paint color from the book of approved color schemes. The selected color scheme must be identified on this request form. Once paint color selection is approved, it is the homeowner's responsibility to contact the contracted painter for the year, the painters may request all changes to be submitted at least 30 days prior to painting. Homeowners are responsible for all costs associated with color changing, or additional painting such as garage doors. Homeowners will need to pay the painting contractor directly for all expenses.
