#### **Introduction and Dialogue with Guests**

Goal of the board is to get involved with the City to maintain the park but it has come to the board's attention that there may be some things that need to be approved by the City before implementation. Josh shared that there has been a lack of communication on both ends and this is something that we are seeking to change.

One project the city is working on is to remove small Ash trees throughout the city. The Board is going to be working with the Parks Department to remove the trees in the park (there are about 10 trees effected by this process). City will replace the Ash trees with a variety of thirty different species. The City wants to work with the HOA to work around the lighting on the trees so the lighting is not damaged. HOA will coordinate with McKay Lighting about relocating the lights.

City will work with HOA on a maintenance plan to maintain the mowing in the park as Walnut Ridge park is one of only two parks in the city that is irrigated. Irrigation creates more challenges for the maintenance crews. The HOA also has asked the City to be mindful of the lighting system as well and Josh and Dennis agree the foreman who is in charge of the park are aware of needing to be mindful of that. Dennis will be involved with approving the improvements in the park.

City has a coordinator of volunteers that will help with neighborhood clean-up projects. They will provide hand tools and a trailer Jena Welch 402-444-6733 is the contact person for that service.
