#### Call to Order- Bob Kipling

- Meeting called to order at 7:02 p.m.
- Meeting minutes from June 23, 2021 HOA meeting were approved. It should be noted in the minutes: the volunteerism of Bob and Jim in fixing the electrical issues at the entrances instead of contracting with an Electrician saved the subdivision \$723 based on a bid we received from McKay Electrical.

#### **Officer Reports:**

#### Treasurer Report - Kathy Kavan

- Financial Statement for June 2021 was sent to the Board before the meeting.
- Financial Report was reviewed and approved by the Board.
- A list of homeowners who have paid their annual dues/special assessment for the fence was reviewed. Approximately 25 homeowners have not paid their 2021 annual dues or special assessment for the fence replacement project. PJ Morgan previously sent out reminders to all homeowners who haven't yet paid their assessment. If not paid by end of August liens will be placed on those properties who are delinquent for 2021.

#### New business

- Annual HOA meeting scheduled to be on August 26 at 7 pm located TBD
- Annual Meeting location Bob will verify with Foundation Bank if the annual HOA meeting can be held there. Alternate plan is to hold the meeting at Porky Butts Restaurant located near 156th and Ruggles St.
- Stained entrance signs Bob, Jim and Laurie are planning to working on scrubbing the entrance signs on an upcoming evening or weekend. The products to clean the signs have been obtained. One of the homeowners near the entrance on Sprague has offered the use of his water to help clean the signs, which will help a lot.

#### • Proposed HOA annual meeting agenda -

## • Architectural & Landscaping Report – Bob Kipling

- **ACR** All submitted ACRs were reviewed and approved prior to the meeting. The Board is committed to reviewing them quickly for homeowners.
- **Entrance signs** Cleaning solution was purchased to scrub the entrance signs at the Sprague Street entrance. HOA Board members are planning to volunteer their time to clean the entrance signs and will set up a date to get this done when dry weather is expected. This will save the subdivision some money.
- **Pruning trees in the park** Need to work on pruning the trees in the park. e.g. removing the suckers from the trees. This is something the City will not do. Plan to ask for volunteers at the annual meeting.

## Secretary Report – Laurie Winkelbauer

- No upcoming events are planned. There won't be a fall dumpster day.
- The annual City of Omaha *Neighborhood Night Out* is on Tuesday August 3. If Walnut Ridge neighbors are wanting to have a block party on their block the HOA is willing to reimburse up to \$100 per block. Receipts must be submitted through PJ Morgan for reimbursement.
