# **Committee Reports**

# Architectural and Landscaping Report/Update

**Park Update**: Dead trees still not acted upon. Calls to City Forrester not returned or passed along to a Scott Shiron from John Wynn. Suggested to send inclusive email copying lead supervisor and all members. They can use the dead trees as mulch for park or other projects.

**Lighting and grant management**: <u>Entrance lighting at 160<sup>th</sup> Street entrance (west side) is out once</u> again. Hannah must contact Hiller for repair.

Cameras destroyed and destruction done in Pavilion once again. Discussed vandal proof trail camera and protective cover box for approximately \$300. Board to decide to pursue for future.

<u>Lighting issues continue in Park</u>. Steve met with Scott Bang from Hiller Electric and discussed work not completed along walkway and front parking area. Discussed sealing some fixtures that show water on inside, replacing bulbs with other option without aluminum wiring, running 120 volt tracer to determine loss of voltage or cut lines, retesting switches in control boxes for proper and "good" contact and as a last resort if present fixtures just cannot be replace then give us a bod/estimate to run lights every 25 feet throughout park. Consensus of Board was that this is the last project for park.

**Fence maintenance and repairs**: Recognition of area needing replacement. Board is saving for the "156<sup>th</sup> Street Fence Replacement Project" to commence within the next two years as the budget holds true. We need all neighbors to realize that the fence along the back of their property is their collective responsibility to keep things off of it and no landscaping to touch it. There have been multiple cases of dirt, grass and landscaping material piled up next to or on fence which cause premature wear and tear/damage to fence. **The Neighbor is ultimately responsible for any and all damage to the fence!** 

# **Safety Report**

OCCP Project and Grant management

Presently at 18 patrollers with more enrolling every month. Neighbors have been thankful and appreciate the presence the Patrol is having in the Neighborhoods. They are reminded that once again your open garage door is the leading cause of all burglary and theft cases in Omaha. 80-90 % of all home invasions/thefts are done through that door being open (according to Douglas County Sheriff's statistics). If you hear a knock at your door in the evening it could very well be a Patrol Member reminding you to be safe and close your door! You don't have to open your door to them but be sure to check for a badge and their uniform shirt.
