Lighting and grant management: Guest from McKay

AJ Coleman brought us up to date as to the present system needs and repairs completed. Park and 160th entrance all working and looking great! Suggested we begin saving for a conversion to LED bulbs and fixtures on a project by project basis which gives us 50,000 hours of bulb life and less maintenance and monthly utility cost but more up-front cost to begin with. Approximate spending is around \$2200 which gives us a one year program for work done. Asked for estimate to put pavilion wiring in conduit and also 156th and Sprague entrance repairs.

Park Update: All fixtures and wiring completed by McKay. Tree removal to be done by City is pending.

Fence maintenance and repairs: No further repairs reported or needed at this time. Future replacement of panel sections to be considered in 2016

OCCP Project and Grant management

Jerry Schulte turned in all receipts to Mayor's office per requirement regarding Citizen Patrol. Patrol now has 21 members that are trained and others with background checks completed for ride along participants. To date, the patrol has logged 563 volunteer hours, driven 1988 miles, contacted neighbors of open garage doors 342 times, reported street light outages to OPPD 65 times, removed 132 illegal signs and actively assisted 5 residents. The Patrol meets once per month (usually the first Sunday of the month) to discuss events/findings/activities and suggestions for improving efficiency.
