## AMENDMENT FOUR TO BY-LAWS OF TUDOR ARMS CONDOMINIUM PROPERTY REGIME 131 SOUTH 39TH STREET OMAHA, NEBRASKA 68131

Tudor Arms Condominium Property Regime (Units 1-12, 14-22, 24-25, Unit L, Garages A-K; FLD Book 15 Number 39170) does hereby amend its By-Laws filed in the office of the Register of Deeds in Douglas County, Nebraska, in Book 1698 at Page (1992) et. Seq. as follows:

- 1. Article V, Section 13, and Amendment Three Paragraph 9, to By-Laws of Tudor Arms Condominium Property Regime are replaced in their entirety by the following: "Common ground space behind garage units and the North Parking Lot is maintained through the monthly dues of all units; Two (2) parking passes shall be issued to each non-garage owning units; parking space behind each garage is reserved for the owner of the garage; parking in the North Lot is on a first come basis. Every car parked in the Tudor Arms North Lot should display its parking pass. Cars parked in the North Lot without passes are subject to being towed, at vehicle owner's expense. Parking passes are the responsibility of each Owner and Co-Owner, are not to be copied, and may be re-issued by the Board from time to time."
- 2. General. These changes were passed by the owners on April 9, 2017; with the new parking rules above voted on and approved, and are being ratified and published by the Board of Directors

as of April 9, 2017. Except as modified hereby, the Master Deed and By-Laws remain in full force and effect.
